

A BYLAW TO PROVIDE FOR ENTERING INTO AN AGREEMENT FOR THE OPERATION AND MAINTENANCE OF THE EATONIA WASTE DISPOSAL GROUNDS

BYLAW NO. 1/2017

The Council of the Rural Municipality of Chesterfield No. 261 in the Province of Saskatchewan, enacts as follows:

1. The Rural Municipality of Chesterfield is hereby authorized to enter into an agreement with the Council of the Town of Eatonia. The terms of which are attached hereto and marked Exhibit "A".

2. The Reeve and Administrator of the Rural Municipality of Chesterfield No 261 are hereby authorized to sign and execute an agreement, the terms of which are set out in Exhibit "A" heretofore referred to.

3. This bylaw shall come into force and take effect on final passing thereof.

PARTNERSHIP AGREEMENT

This Partnership Agreement made this 13 day of December, 2016 between the

TOWN OF EATONIA

and

R.M. OF CHESTERFIELD NO. 261

This agreement sets forth the terms of understanding between the Town of Eatonia and the R.M. of Chesterfield No. 261.

1. Purpose

To operate and maintain the Eatonia Waste Disposal Grounds located at the south end of quarter section NW-26-25-25-W3rd.

2. Effective Time Frame

The term shall be effective from the 1st day of January, 2017 and shall continue until terminated in writing by either municipal council.

3. Funding

Each municipality will pay for the following:

Town of Eatonia:	<ul style="list-style-type: none"> ➤ Provide cell phone for custodian to use and pay for monthly cell phone plan ➤ Pay for propane to heat the nuisance grounds shack ➤ Pay for the fuel for the lawn mower and fire starter for the wood pile
R.M of Chesterfield No. 261	<ul style="list-style-type: none"> ➤ Pay the wages of the Pest Control Officer and poison to control rats at the nuisance grounds ➤ Maintain the road into the nuisance grounds
Town of Eatonia & R.M. of Chesterfield Shared	<ul style="list-style-type: none"> ➤ Custodian contract wages ➤ Repairs to the nuisance grounds shack and fence ➤ Unforeseen repairs to the pay loader while cleaning up at the nuisance grounds ➤ Cost of the custom work to clean up at the nuisance grounds

4. Evaluation

Both municipalities shall review this agreement on an annual basis.
